(a) "you" and "your" means the person accepting billing is and will be responsible for the remaining balance on your agreement. With an understanding that \$300.00 deposit has been paid in advance.
- 2) N.S.F; Non-sufficient funds, if any cheque (s) issued by name or company is returned to Perfect Sounds DJ Services bank for any reason the customer shall upon being informed by phone or email must immediately re-issue Perfect Sounds DJ Services remaining as well a N.S.F fee of \$20.00.
- 3) Equipment; Perfect Sounds DJ Services is the sole owner of all audio equipment on the premise of the event stated on this agreement. All sound and computers with lighting and any other products brought by us is also sole property/ownership of Perfect Sounds DJ Services.
- 4) Insurance/Licenses; Perfect Sounds DJ Services is insured with liability insurance of \$2M coverage, with CONNECT License to play pre-recorded music. Socan is not the responsibility of Perfect Sounds DJ Services, it's the sole response of the customer to find the proper information, further details call Socan 1-800-557-6226.
- 5) Music; As stated our music is licensed by CONNECT Music and approved, our music is purchased from local suppliers. We can't guarantee that we will have every song in the whole world, we carry the most popular and requested songs since 1935. If our company doesn't have it, customer has the right to supply us with the music of their choice.
- 6) Electricity; Is supplied by the person who hires us and the establishment they booked. Out-door events are also provided by customer or otherwise generator is provided at additional cost to the customer. 1 outlet must also be provided within 10ft. with a 6ft. table of the DJ's location.
- 7) People; When the person on the agreement or couple have left the building early then stated on the agreement and we have only 18 people or less remaining we will have the right to pack-up and end the party.
- 8) Cancellation; If for any reason after the deposit has been paid that the function stated on the front is cancelled, changed, nature of God, health, or booked another establishment because they have an in-house DJ, you will have the opportunity to use the deposit again providing it's on the same calendar year, otherwise deposits are non-refundable. Dates are subject to availability.
- 9) Drunk(s)/Damages; Perfect Sounds DJ Services is not responsible for anyone who drinks more than the by-law limits. If anyone at the event damages/spills/or destroys any Perfect Sounds DJ Services property and that has signed this agreement will be totally liable of the cost to replace and applies to also the person(s) that did the damage.
- 10) Health; Perfect Sounds DJ Services is not responsible of any deaths or anyone that falls, falls ill due to poor health and over exerting themselves, dancing, drinking, smoking, taking medication, illegal drugs/pills, will not be Perfect Sounds DJ Services responsibility.
